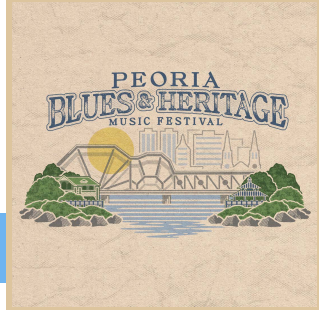

Vendor must provide:

Complete Booth including, but not limited to: All signage, which must be approved by Promoter. Vendor must provide all equipment, furniture, fixtures, tent/overhead covering, adequate product and product quantities, etc. necessary to insure a successful vendor operation.

All applicable permits and or licenses: There is a \$20 City of Peoria Vendor Permit that is necessary to obtain. VENDOR WILL PAY PROMOTER THE CITY OF PEORIA VENDOR PERMIT FEE. Vendor will pay all applicable taxes including State of Illinois Sales tax.

Vendor is responsible for the security of all equipment, product, and personal effects during the Peoria Blues & Heritage Music Festival. Promoter will provide overnight security on Friday only, however; Promoter takes no responsibility for any losses incurred through theft, carelessness, force majeure, weather related events, riots, power outage or power surges, etc.

Vendor shall make extra effort to oversee all areas immediately surrounding his/her booth to avoid accumulation of trash and residue. Vendor is responsible for any damage to the grounds resulting from Vendor's operations during the Peoria Blues & Heritage Music Festival. Designated fire lanes must be kept clear at all times. Vendor must schedule time with Vendor Manager in advance before showing up on site to set-up.

All supply vehicles MUST be removed from the site at least one hour prior to the opening of the gates for that day. Vehicles will be allowed to enter grounds for restocking purposes only.

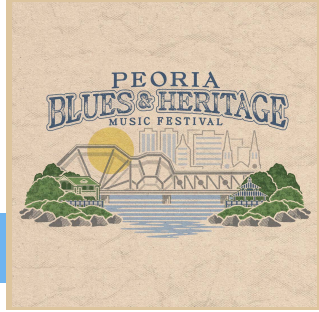
